1. ADMISSION DETAILS

2. REPORTING & ADMISSION INSTRUCTIONS

1. All provisionally selected DUAT and Non-DUAT candidates must report personally to the P.G. Department of Commerce, D.H.S.K. Commerce College, Dibrugarh, on 13 August 2026.
2. Candidates must report at 11:00 AM onwards and are strictly advised to reach the College before the reporting time so that verification and admission formalities can be completed smoothly.
3. Admission shall be subject to verification of eligibility, original documents, category claims (where applicable), and the relevant DUAT/PG Entrance Test score.
4. Selection shall remain provisional until all documents and eligibility requirements have been successfully verified.
5. Candidates must personally complete the admission formalities and provide correct, complete and consistent information in all documents/forms.
6. Candidates should arrange their documents in the order given below and carry one complete set of self-attested photocopies in addition to the originals.

Graduation/B.Com. Certificate	Degree/pass certificate or provisional pass certificate, wherever already issued.
Class X Documents	Class X/HSLC mark sheet and pass certificate.
Class XII Documents	Class XII/Higher Secondary mark sheet and pass certificate.
Caste/Category Certificate	Valid SC/ST/OBC/MOBC or other applicable category certificate, if admission is claimed under a reserved category.
NCL Certificate	Valid Non-Creamy Layer (NCL) certificate for OBC/MOBC candidates, wherever applicable.
EWS Certificate	Valid EWS certificate, wherever applicable.

4. DOCUMENT VERIFICATION

1. All original documents must be produced for verification. Photocopies will not be accepted in place of originals for verification.
2. The photocopies submitted should be clear and self-attested by the candidate.
3. The name, date of birth, category and other personal particulars should be consistent across the submitted documents. Any discrepancy must be brought to the notice of the admission committee.
4. Candidates claiming reservation must produce the applicable valid certificate.
5. Candidates must ensure that their DUAT/PG Entrance Test score details correspond to the score submitted/used for admission.

5. FEE & COMPLETION OF ADMISSION

1. The admission fee is ₹25,500/- (Rupees Twenty-Five Thousand Five Hundred only) for one year.
2. Candidates are required to complete the prescribed fee payment and other admission formalities as instructed by the Department.
3. Candidates must collect and safely retain the admission/fee receipt for future reference.
4. Admission will be treated as complete only after successful document verification and completion of the prescribed admission and fee formalities.

6. IMPORTANT NOTE

Candidates failing to report on time or failing to produce the required documents may have to wait for further instructions, and admission shall remain subject to verification, applicable rules and availability of seats. The College/Department reserves the right to withhold or cancel admission if any information or document is found to be incorrect, incomplete or invalid.

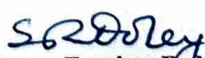
